





## Telling your District's Story


- Many staff may not know much or anything about Impact Aid
  - Be ready to educate them on the purpose and overview of the program
  - Use details from your own district to illustrate the importance of the funding
  - If applicable, demonstrate the difference between your actual funding and your full funding amount – this will illustrate the need for increased funding
- Even staff who are well versed on the issue may not know about all parts of the program
  - Use the state databases to illustrate each funding stream
  - If your district receives Children With Disabilities (CWD) funding, be sure to emphasize both how important that funding is and how little of the actual cost of educating these students is covered by IDEA and CWD



## TALKING POINTS: YOUR DISTRICT'S STORY


- Tell the specifics of your federal impaction your school community and the financial impacts.
  - Be clear about the difference between your current funding and what full funding would look like for your district, especially if you are a mid-to-low LOT district.
- If your district receives Children With Disabilities funding, tell them about your special education population, services, and costs.
  - Emphasize the gap between your IDEA and CWD funding and the actual costs of educating these students.

## President's Request


- As in past years, President Trump's budget
  - Eliminates Federal Property
  - Level-funds all other sections
- Cuts funding to the Department of Education by 8 percent
- Creates block grant for all other K-12 programs
  - 29 programs consolidated into state block grant
- Increases funding for special education and career and technical education
- Prioritizes school choice through tax credit program



## Secretary DeVos on 7002 Elimination


Blunt – "Impact Aid replaces only a portion of what the property tax would have been. Why do you continue to propose eliminating that?"

DeVos – "Well, to be clear ... it's only a portion of the Impact Aid that we've suggested eliminating ... The part without students connected to it. I think they're mostly urban. These are all, Atlanta, New York, Philadelphia, Kansas City, Denver, Seattle, San Francisco, Chicago, and Boston."




## FY 2021 Appropriations

- Budget Caps
  - The threat of sequester is over we raised the budget caps for FY20 and FY21
    - Non-Defense Discretionary received an extra \$24.5 billion in FY20
    - Will only see an extra \$5 billion in FY21



## Budget Deal Raised NDD Caps for FY20 & FY21








## FY19 and FY20 Impact Aid Funding

- FY19 Funding: +\$32M for Impact Aid
  - \$31M Basic Support; \$1M Federal Property
- FY20 Funding: +\$40M for Impact Aid
  - \$39M Basic Support; \$1M Federal Property
- FY21 President's Request: -\$75M for Impact Aid
  - Eliminates Federal Property funding
- FY21 NAFIS Request: +\$52M for Impact Aid
  - \$50M Basic Support; \$2M Federal Property









  - Republicans contact Devin Barrett (Inhofe)



## **School Facilities Report Overview**


- 218 NAFIS member responses
- \$4.2B+ in pressing facility needs






## Impact Aid Infrastructure Act (House)

- H.R. 3647: The Impact Aid Infrastructure Act
  - Introduced in the House by TJ Cox (D-CA) and Don Young (R-AK)
    - Has 11 total co-sponsors
- Would add a one-time infusion of \$1 billion to the Impact Aid construction line item
  - Would run though Impact Aid construction formula 40% to formula, 60% to competitive



## Impact Aid Infrastructure Act (Senate)

- To be introduced by Senator Hirono (D-HI)
  - Indian lands allocations unchanged
  - Military eligibility threshold changed to reflect eligibility for DoD Impact Aid supplemental program
- Looking for a Republican cosponsor




## Impact Aid Infrastructure Act Talking Points

- NAFIS has identified over \$4.2 billion in pressing school facility needs at NAFIS member school districts.
- Federally impacted school districts have limited or no bonding capacity due to the
  presence of nontaxable Federal property. In recognition of this fact, the Impact Aid
  law has included a construction line item since its inception.
- This is not a State or local responsibility the Federal government already recognizes its responsibility in federally impacted school districts.
- Federally impacted school districts need adequate resources to address health and safety code violations and capacity issues that come with educating students in buildings that are, in some cases, over 100 years old, as well as to ensure all students have access to 21<sup>st</sup> century learning environments. Impact Aid construction funding falls far short of need.
- The staffing and management capacity is already in place at the Department of Education to get funding for shovel-ready projects out the door through any major



### Rebuild America's Schools Act


- Would create a \$100 billion school infrastructure program, including grants and loan assistance available to all public schools.
  - Includes \$500 million to go through the Impact Aid construction line



### TALKING POINTS: INFRASTRUCTURE

- House: CO-SPONSOR the Impact Aid Infrastructure Act
- Senate: CO-SPONSOR Senate companion
- SUPPORT the Rebuild America's Schools Act
- Include schools in a broad infrastructure package
  - We need to make our schools part of the infrastructure conversation!


## Education Savings Accounts for Military Families Act of 2019

- Education Savings Accounts for Military Families Act of 2019
  - House Introduced by Rep. Banks (IN)
  - Senate Introduced by Senators Sasse (NE), Scott (SC), Cotton (AR)
- Would provide \$6,000 per year for military connected children for most any educational expense
  - As long as the student does not attend public school full-time and attended public school for at least 100 consecutive days of the previous school year
- Written as an amendment to Title VII of ESSA Impact Aid
  - The Impact Aid Title
- \$1.2 billion authorization
  - No Pay-For
  - Written to be another line item in Impact Aid appropriations



## Education Savings Accounts for Military Families Act of 2019

- The good news:
  - The bills did not make it into the NDAA
  - Little chance of moving elsewhere this year
- The bad news:
  - The Heritage Foundation is including cosponsorship in their legislator scorecard
  - The Senate bill has 6 co-sponsors
  - The House bill has 88 co-sponsors




# Continuing your Advocacy




## Advocacy is a marathon

  - Can help organize visits, meetings in the district

  - Thank you cards on your tables




## Stay in touch!
