## **South Dakota School Districts Receive More Than \$72 Million in Impact Aid**

*New NAFIS reports show distribution of funds by state, school district and congressional district*

**Washington, DC – November 13, 2019** – The National Association of Federally Impacted Schools (NAFIS) yesterday released [Impact Aid Payments Overview: Fiscal Year 2018 Section 7003 – Basic Support](#) and [Impact Aid Payments Overview: Fiscal Year 2018 Section 7002 – Federal Property](#). These publications detail how Impact Aid funds were distributed to local education agencies across the United States and its territories – and South Dakota school districts receive more than \$72 million, among the highest in the nation.

According to FY 2018 data from the U.S. Department of Education (the most recent available), South Dakota schools received \$67 million in Basic Support funding, and \$1.6 million in Impact Aid Children with Disabilities funding. They also received \$3.5 million in Federal Property funding.

Thirty-eight South Dakota school districts serving more than 17,000 students benefit from these funds. Nationally, approximately \$1.4 billion in Impact Aid appropriations supported 1,253 school districts serving around 10 million students.

Impact Aid is a Federal education program that partially reimburses school districts for the lost revenue and additional costs associated with the presence of nontaxable Federal property, such as military installations, Indian trust or treaty lands, Federal low-rent housing, national parks, national laboratories and other Federal buildings and property. Because most school districts are funded largely through local taxes and fees, and because Federal land is exempt from taxation, districts containing Federal property are at a financial disadvantage in funding their schools. Impact Aid (Title VII of the Every Student Succeeds Act, ESSA) recognizes the Federal government's obligation to help finance public education and support students in areas where it holds land, though it hasn't been fully funded since 1969.

"South Dakota Impact Aid school districts depend on this funding to help pay for teacher salaries, student transportation, school construction, social emotional supports, instructional materials and much more," said Max Schochenmaier, Executive Director of Impact Schools of South Dakota (ISSD). "These funds are critical to ensuring South Dakota students have access to a quality education."

"Impact Aid plays an important role in school districts' efforts to provide all students with the opportunities they need to meet their full potential," said NAFIS Executive Director Hilary Goldmann. "These publications highlight the diversity of federally impacted school districts, and they make clear

that some school districts and the students they serve are being shortchanged hundreds of thousands of dollars because the program is not fully funded.”

The reports aim to raise the awareness of federal, state and local policymakers of the importance of Impact Aid to individual school districts and states. The publications, along with an infographic offering a national snapshot of the program, can be found on the [NAFIS website](#).
