Superintendent Jeff Limore Elected Region V Director of NAFIS Board

Washington, DC – April 7, 2021 – The National Association of Federally Impacted Schools (NAFIS) is pleased to announce that Jeff Limore, Superintendent of Dahlongegah Public Schools, has been re-elected to the NAFIS Board of Directors. He represents Region V, which includes Texas, Oklahoma, New Mexico, Colorado and Utah. The election took place at the 2021 NAFIS Spring Virtual Conference.

As a member of the NAFIS Board of Directors, Limore serves as a national leader advocating for school districts that receive Impact Aid. In this role, he works with the other board members from across the country to guide the association's public policy work and oversee plans for the association.

Impact Aid reimburses school districts for the loss of revenue caused by the presence of nontaxable Federal property, including military installations; Indian Trust, Treaty and Alaska Native Claims Settlement Act lands; Federal low-income housing facilities; and national laboratories and other Federal buildings and property. It helps ensure students who attend schools on or near Federal property have access to a quality education.

Limore has sat on the NAFIS Board of Directors for the past five years, and he has served on the nomination, bylaws, strategic planning and Federal Relations Outreach (FRO) committees. He is also a longstanding member of the National Indian Impacted Schools Association (NIISA) Executive Board and currently serves as its Past President.

Limore brings 22 years of experience as a superintendent to his position on the board. He also has a background in teaching and counseling for 14 years prior.

"Impact Aid is vital to our school," said Limore. "We use it for funding basic support, and it would be nearly impossible for us to exist without it. I am proud to be a member of NAFIS and the NIISA family. The organization has grown to record membership in the last few years, and it is so exciting to be a part of the increased membership growth from Oklahoma."

"The NAFIS Board plays a critical role in ensuring students in federally impacted school districts have access to the opportunities they need to reach their full potential," said NAFIS Executive Director Hilary Goldmann. "Jeff brings important insight into the needs of these school districts, their students and their communities that will help shape NAFIS advocacy, as well as a wealth of experience and ideas from which the association will continue to benefit."

Limore's term will last for two years.

The National Association of Federally Impacted Schools (NAFIS) represents the 1,100-plus federally impacted public school districts that together educate more than 10 million students across the nation. Federally impacted school districts are those located on or near nontaxable Federal property—including military installations; Indian Trust, Treaty and Alaska Native Claims Settlement Act lands; Federal low income housing facilities; and national parks, national laboratories and other Federal buildings and property. These school districts, which are demographically and geographically diverse, receive Impact Aid, a Federal education program that reimburses school districts for the lost local revenue and additional costs associated with the presence of Federal property.
